## **ORDER**

As per the G.O read as 3rd, the Government of Kerala have sanctioned the Course B.Com with C.A degree programme in Aided stream to the MES Keveeyem College, (Aided), Valanchery, Malappuram for the academic year 2013-2014. But no formal application has been received for the Courses from the College to the University.

The Principal,MES Keveeyem College,(Aided), Valanchery, Malappuram applied for additional affiliation for various degree programmes in the college as per the application read as 1<sup>st</sup>. As per the District Level Inspection Commission Report dated 25.2.2014 the course B.Com with C.Awas recommended for the College.

As per the GO (Ms) No.615/13/HEdn dated 12.9.2013 the Govt of Kerala have sanctioned new course in the Aided stream with the condition that the University should sanction the course in Aided stream, only if the admission process has not started/classes are not started for the sanctioned Courses in the unaided stream.

As per the syndicate resolution dated 20-09-13, item no.2013.985, the syndicate has resolved to implement GO (Ms) No.615/13/HEdn dated 12.9.2013 subject to the condition that the courses/syllabus are approved by the concerned bodies and all the colleges create adequate infrastructure facilities.

As per the syndicate resolution item no.2013.1059 dated 20-09-13, the syndicate approved the question of granting affiliation to the newly sanctioned courses by the Government of Kerala as per the GO (Ms) No.615/13/HEdn. dated 12.9.2013 for the academic year 2013-2014 in all government and government aided colleges with verification if necessary.

As per the U O No.4648/2013/CU dated 09.10.2013, the G O (Ms) No.615/13/HEdn dated 12.9.2013 was implemented with many terms and conditions which are to be strictly followed by the College in all respects.

In the Note of the Vice Chancellor dated 7.10.2013, it was specified that, conversion of students admitted in unaided courses to the aided courses will not be permitted in any case and if any of the courses are allowed in the unaided sector and admission process to which has not been made during the academic year such courses alone will be allowed to start under the aided sector.

The College has submitted the undertaking to the effect that they have not started BCom Computer Application in their College.

The Principal and the Manager, MES Keveeyem College, (Aided), Valanchery, Malappuram have submitted an undertaking to the effect that the college shall carry out faithfully the provisions of the University Act, Statutes, Ordinances and Regulations and directions issued by the University from time to time and admit only such students who are eligible as per the regulations of the University. They have also agreed that the University can proceed with strict actions including withdrawal of affiliation of the college, if anything is done by them against the interest of the University or the student community.

An amount of Rs 5000/-has been remitted by the college towards the affiliation fee as per the chalan dated 19.7.2014 remitted at SBT.

As per the Syndicate Resolution item No.2014.486 dated 12.7.2014,the Syndicate has approved the question Bcom with C.A Aided degree programme with an intake of 30 students in MES Keveeyem College, Valancher

Considering the above, sanction is accorded for granting provisional affiliation for starting the new Aided cours Keveeyem College, (Aided), Valanchery, Malappuram for the academic year 2014-2015 as detailed below.
