ORDER

The Principal MES Keveeyem College, (Aided), Valanchery, Malappuram applied for additional affiliation for various degree programmes in the college as per the application read as 1st.

As per the letter read as second these degree programmes were recommended and forwarded for the consideration and concurrence of the Govt.of Kerala.

As per the reference read as 3rd BCA, MA English and Mcom degree programmes were sanctioned to the College in self financing mode, on the basis of the Government Sanction for the courses for the academic year 2013-2014.

As per the GO read as 4th the Government of Kerala have sanctioned the Courses Bcom with C.A and Mcom degree programmes in Aided stream to the College for the academic year 2013-2014.

n a letter dated 4.10.2013,the College had requested to change the affiliation granted for Mcom in self finance sector to the techsector and issue orders accordingly for the academic year 2013-2014.

As per the GO (Ms) No.615/13/HEdn dated 12.9.2013 the Govt of Kerala have sanctioned new courses in the Aided stream with the condition that the University should sanction the course in Aided stream, only if the admission process has not started/classes are not started for the sanctioned Courses in the unaided stream.

As per the syndicate resolution dated 20-09-13, item no. 2013.985, the syndicate has resolved to implement GO (Ms) No.615/13/HEdn dated 12.9.2013 subject to the condition that the courses/syllabus are approved by the concerned bodies and all the colleges create adequate infrastructure facilities.

As per the syndicate resolution dated 20-09-13, item no.2013.1059,the syndicate approved the question of granting affiliation to the newly sanctioned courses by the Government of Kerala as per the GO (Ms) No.615/13/HEdn. dated 12.9.2013 for the academic year 2013-2014 in all government and government aided colleges with verification if necessary.

As per the U O No.4648/2013/CU dated 9.10.2013, the G O (Ms) No.615/13/HEdn dated 12.9.2013 was implemented with vanylerms and conditions which are to be strictly followed by the College in all respects.

n the Note of the V.C dated 7.10.2013, it is specified that, conversion of students admitted in unaided courses to the ed courses will not be permitted in any case and if any of the courses are allowed in the unaided sector and admission to which has not been made during the academic year such courses alone will be allowed to start under the aided

Now the College has submitted an undertaking dated 20.12.2013 to the effect that they have not started M.Com under
