As per the letter read as second, this office forwarded recommendation for MCom-12, Msc Physics-12, MA History-16, Bsc Geology-24 and Bsc Psychology-24 seats degree programmes to the College for the consideration and concurrence of the Govt.of Kerala.

The Govt.of Kerala have issued No Objection Certificate for starting the new self financing degree programme **Msc Physics with 12 seats** in the college for the academic year 2014-2015 as per the GO read as 3<sup>rd</sup>.

The Principal and the Manager, M E S Keveeyem College (Aided) Valanchery, Malappuram have submitted an undertaking to the effect that the college shall carry out faithfully the provisions of the University Act, Statutes, Ordinances and Regulations and directions issued by the University from time to time and admit only such students who are eligible as per the regulations of the University. They have also agreed that the University can proceed with strict actions including withdrawal of affiliation of the college, if anything is done by them, against the interest of the University or the student community.

An amount of Rs.5000/- has been remitted by the college towards affiliation fee as per chalan number 141359051 dated 15.10.2014 at SBT.

As per the Syndicate Resolution dated 12-05-14, Item No.2014.426\*, the Syndicate authorized the Vice Chancellor to take appropriate decision in the question of starting new courses in the existing Colleges for the academic year 2014-2015.



Under the above circumstances, sanction is accorded by the Vice Chancellor on 06-  
additional affiliation to the self financing course as detailed below in the College for the ac  
2015 and subject to the terms and conditions specified hereunder.
