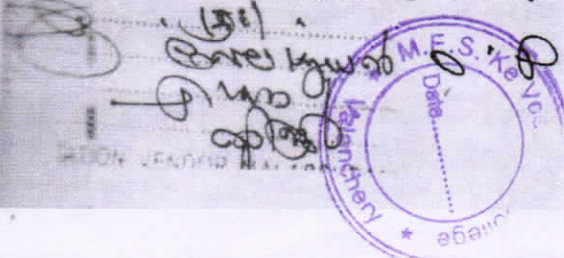

5. Aims and Objectives :

10. POWER, DUTIES AND RESPONSIBILITIES:

A. Executive Committee:

- a. The President and in his absence, one of the Vice Presidents shall preside over and direct the proceedings of the meetings.
- b. If both the President and Vice Presidents are absent for a meeting, any member of the committee shall be elected to the chair and he or she shall have all powers of the President so far as the proceedings of that meeting are concerned.
- c. The presiding officer shall have only one casting vote.
- d. The Secretary shall conduct the correspondence convene meetings, maintain necessary files and records and shall perform such other duties as are necessary for the working of the association. In the absence of the Secretary, Joint Secretaries shall perform the duties as decided by the executive committee.
- e. The Treasurer shall receive all money payable to the Association, Issue receipts, Disburse all payments and keep proper accounts and shall be the custodian of the funds of the association.
- f. The members of the executive committee shall render honorary service.

B. General Body:

- a. A past student of the college shall be eligible for enrolment as a member of the association on payment of the prescribed membership fee.
- b. Former and existing Principals and staff of the college shall be eligible for membership on payment of the prescribed membership fee even though they are not old students of the college.

- h. The Secretary should call the Annual General Body Meeting every year in the month of December (2nd Saturday) and elect new Governing Council and file the newly elected governing council list before the District Registrar (General) within 14 (Fourteen) day from the date of election.

4. Joint Secretary:

The joint secretaries shall exercise all such power of the Secretary in his absence and shall assist the General secretary in execution of his duties and responsibilities.

5. Treasurer:

- a. The treasurer shall be the authorised person on all financial matters, supervise all financial transactions and cause to maintain and supervise account records of the association.
- b. Shall prepare yearly statement of accounts and the same shall be presented before the executive committee for approval.
- c. He shall mobilise the funds required for implementing the programmes of the association and for meetings.
- d. The members of the executive committee shall assist the treasurer in discharge of the duties and when required and as authorised by executive committee

6. Auditors:

The auditors elected from the General Body should audit the financial transactions and books and accounts of the society.

14. FUNDS & ITS UTILISATION:

The source of the income of the Association will be Membership Fees, Subscriptions, Donations, Aid from Government or Non-Government institutions, other financing institutions and voluntary agencies, and Special

fund raised by arranging any other fund raising programmes. The available funds of the society shall be exclusively used for achieving the aims and objectives of the society only. No funds will be kept by the members or distribute among members.

- a) **Bank Account** - The funds of the association shall be deposited in Joint Account in the name of the College Principal, General Secretary and Treasurer in Punjab National Bank and the account shall be operated up on jointly by the Principal, General Secretary and Treasurer. The Treasurer shall not normally keep with him cash in excess of Rs.10,000/- (Ten Thousand only) to meet emergent items of expenditure.
- b) The whole or any part of funds, other assets or income of the association shall not be transferred or applied at any time for any purpose other than those declared in these bye-laws or approved by the General Body or Executive Committee.
- c) In the vent of extinction of the Association the properties and other assets of the association shall be handed over to a charitable institution having objects similar to those declared in these bye-laws.

15. BYE-LAW AMENDMENTS.

None of the Bye Law of this Association shall be altered, amended rescinded or added to except at a General Body Meeting of the members of the Association and without the vote of at least a majority of (3/5) Three - Fifth of the members present at such meeting. The alteration, amendment, rescission or addition shall be specified in the Agenda of Meeting. The amendment of bye law will be according to the Clause 12 of Indian Societies Registration Act XXI of 1860.

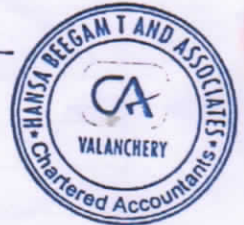
