NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

1. The first party will act as a mentor and second party will act as a mentee under the PARAMARSH scheme of UGC
2. The main objective of the PARAMARSH scheme is enhance the overall quality of mentee institutions to enable them to get accredited
3. The first party will organize training and workshops to faculty and staff members of the second party on the process of accreditation, documentation and presentation.
4. The financial support for the programme will be provided by the MHRD, Govt. of India through the mentor institution.
5. The mentoring shall be imparted through the Internal Quality Assurance Cell (IQAC) of the mentor institution.
6. The mentoring process will be done under the stewardship of an accreditation ambassador.
7. The mentee institution shall nominate a full faculty as the institutional coordinator for the project.
8. The duration of the project will be one year
