### MEMORANDUM OF UNDERSTANDING

# TALROP EDUCATIONS PRIVATE LIMITED, KERALA, INDIA and (Institute Name, Location)

#### PREAMBLE

- 2. Talrop's dedicated team will endeavor to help in making job opportunities available to the students who are interested to work with Talrop.
- 3. To provide cyber awareness programmes for the personnel and people associated with the Institute, through various means thereby resulting in increased chances of digital awareness.
- 4. To provide Information and Communications Technology (ICT) training for the personnel and people associated with the Institute ,through various seminars and workshops thereby resulting in increased chances of digital literacy.
- 5. To provide informative articles and content delivered through website/platform to improve digital awareness and digital literacy
- 6. To conduct workshops and seminars, for the Personnel and Students of the Institute, and Parents associated with the Institute, as prevalent in the IT Industry along with submission of comprehensive performance reports of the students participating in Talrop Courses. This shall help to identify the skill level of the learners and take proactive measures.

- 2. The Institute shall take all steps necessary to communicate to its affiliated institutions and colleges about the Talrop's services subscribed under this MoU and ensure that the candidates register themselves on the platform.
- 3. Institute shall be solely responsible for the Talrop's services appropriated by it under this MoU to users and / or candidates. Institute further undertakes that the Services subscribed by it under this MoU are solely for the purpose of its proper appropriation to the users and/or candidates and not for its commercial use / resale purpose.
- 4. Institute shall bear the expenses for the services subscribed from Talrop and also bear any cost incurred for programmes conducted at the campus of the Institute by Talrop at the former's request.

- 3. The Memorandum of understanding or any part thereof may be amended at any time during its tenure only by consent in writing of the parties.
- 4. The Memorandum of Understanding is not intended to create any legal relation of employer-employee or of principal and agent amongst the parties.
- 5. This Memorandum of Understanding shall remain valid for a period of One Year from the date of its signing, and can be extended on mutual terms and conditions.
- 6. This Memorandum of Understanding may be amended or terminated earlier by mutual written MoU of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. Early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any other MoU entered into pursuant to this MOU, whose obligations shall cease to exist.
- 7. Through this Memorandum of Understanding, Talrop and Institute affirm their commitment to fulfill and achieve the objectives mutually agreed upon in this Memorandum of Understanding.

This MOU is executed in duplicate with each copy being an official version of the MoU and having equal validity. IN WITNESS WHEREOF, the parties hereto have executed this MOU, have caused their proper and duly authorised officers to execute and deliver this MoU as of the day and year first above written.
