Heads of the Institution may mutually alter the dates if such duties of assigned faculty members are seen to hamper important academic or evaluation assignments at his/her place of posting.

Access to College Library: Students will have access to college Library after taking permission from College Librarian for their research/reference purpose.

Joint organization of Seminars/Symposia/Workshop: Seminars/Symposia/Workshop may be jointly organized by faculty members of both the CPA College of Global Studies and MES Keveeyam College Valanchery.

Joint Organization of Placement drive: CPA College of Global Studies and MES Keveeyam College Valanchery will jointly organize placement drives for the benefit of the outgoing and passes out students.

Guidance in Career counseling: CPA College of Global Studies and MES Keveeyam College Valanchery

Will share information on career counseling and opportunities for higher studies in India and abroad.

Joint Field work: Both the colleges may jointly organize filed works which are part of the curriculum. This way both the institutions may utilize the expertise of individual faculty members for the benefit of the students

This is a non-binding MoU and there shall be no financial obligation on the part of both CPA College of Global Studies and MES Keveeyam College Valanchery.


In any other circumstances or other detailed collaboration between the two parties, a separate MoU shall be drawn up as and when required.

Whereas the above parties recognize that academic collaboration would be of mutual benefit and would provide strengths in the development in the professional education of the students and their mutual interest in engaging themselves in academic cooperation

NOWHEREFORE, in consideration of the mutual promises and undertakings contained in this MOU, the parties agree as follows:

The MOU provides

1. For giving coaching classes for the above professional courses to the students studying in the college and opting for joining the coaching classes to prepare for the exams of the courses.

10. The Institution would provide Internship and placements as per the requirement of the course.


